Additional Terms, Conditions and Important Information:

1. Vendor space is limited. Vendors will be accepted on a first come, first served basis. If upon receipt of Vendor Contract, all booths have been filled, the vendor will be given an option to either receive a refund or to be placed on the vendor waiting list. If the vendor is not provided booth space from the waiting list, a full refund will be given after the show is over.
2. Vendor fees are due at time of registration.
3. Vendor show fee includes
 - * 10 x 10 booth, 2 chairs
 - * Vendor listing in Heart of Arkansas Show Booklet
 - * Listing on Facebook Page and www.quilttalk.org website and link to vendor website if applicable.
4. Tables must be draped to the floor unless the items under the table are for sale and displayed tastefully.
5. No nailing or affixing any objects to the property of Bishop Park.
6. No unloading prior to commencement of set-up and no packing up prior to the closing time stated in this contract.
7. Vendor booth must remain open during all show hours.
8. All merchandise must be removed in a timely fashion Saturday afternoon at the close of the Show. Trash around your booth must be removed.
9. Arkansas State Law requires retailers to collect and remit applicable sales tax on all sales in the State of Arkansas.
10. **Vendor will provide at least one door prize to be given away during the show.**
You will turn it in to the Door Prize Booth at set-up.
11. Saline County Quilters' Guild member volunteers are available to sit in your booth and relieve you for short periods. Refreshments will be offered to you in our Hospitality Area.
12. Booth sharing or subletting is allowed only with prior written consent of the Heart of Arkansas Quilt Show and the Saline County Quilters' Guild.
13. **Cancellation policy:** Requests for cancellation must be submitted in writing to Illine Smith, 23614 S. Springlake Road, Hensley, AR 72065. A full refund will be given for any cancellations made prior to July 1, 2027. A 50% refund will be given on cancellations made between July 1, 2027 and August 1, 2027. After August 1, 2027, no refunds will be given.
